Please find enclosed a copy of a restraining order recently made in your favour by this Court in an action against the person named in it, the defendant. The copy has been sent to you to ensure that you are fully aware of the conditions of the order, and of the extent to which you are protected by it.

You are not protected by the restraining order until the defendant has received a copy of the order.

If you wish to find out whether the defendant has received a copy of the order, you should contact your 24 hour Police Station.

Although the police assign a high priority to the serving of restraining orders, in the majority of cases it still takes several days for the defendant to receive the copy of the order.

If the defendant approaches you, or if the police have had difficulty locating the defendant and you happen to see the defendant, you should **contact the police immediately**.

It is important to remember that if the person who has been restrained breaches the order, that is, disobeys a condition of it, you should **contact the police immediately** so that the necessary action can be taken.

Two spare copies of the restraining order have also been sent to you. You should keep them to hand in a safe place. If the order has not been served, and the defendant approaches you in person (or if the police have been having difficulty in locating the defendant and you happen to see him or her), you should contact the police immediately. When the police attend, you can then give them the spare copies of the order to enable personal service of the restraining order to be effected on the defendant immediately.






