* I am contacting you on the advice of your representative Cristina, Sydney on reporting a case of Malicious Fraudulent Activity that has occurred in my business account JC INNOVATIONS, customer # [REDACTED]

* The Fraudulent activity targeting my accounts has been occurring over a 10 year period and has targeted numerous accounts, Utility accounts, Phone accounts, email accounts, computer hacking, Centrelink accounts and recently Netbank electronic transfers to my Publishing House Austin Macauley Publishers, London, which has been reported to the Commonwealth Bank today and placed with the Fraud Division for investigation. On Thursday i have reported Fraudulent Activity occurring for the second time in my Telstra Mobile phone business account that has Restricted Access because of the previous Fraudulent Activity that has occurred in my personal accounts with 2 different servers. This report was made in the Telstra Store, Kadina and escalated to requesting contact with Telstra Head office CEO for investigation and reported as continuous Fraudulent Activity. * IDENTIFIED AS

* POLICE + GOVERNMENT SOURCE - REMOTE ACCESS TO SERVERS.
I was informed by a representative of your company to contact and report any unusual activity or suspicious activity occurs during the setup process of this account, as i had informed the representative of the previous hacking of my previous computer system and email account, which resulted in 136,000 malware report on that computer.

Following this report of the malware i purchased a new computer system registered in my registered business name and professionally setup by a Computer technician, which included numerous Security systems, newly created accounts and emails and my newly created business phone account and new phone number. This newly created accounts and business computer were registered under the business registration JC INNOVATIONS and not as a personal user.

* On start up of the new computer system i received 96 hacking attempts in 2 days* which prompted me to get the support of the IT Specialist Pitstop Technologies, Kadina for the computer set up and Security measures installed

Following this new set up of the computer, newly created business phone account and newly created accounts i started to receive suspicious sign ins and suspicious activity in these accounts.

* Following the publication of my novel 31st October 2020 connected to the email [REDACTED] started to receive blocked access to Social Media, suspicious sign ins to social media, blocked contact with my publishing house, fraudulent emails coming through to the synchronised email of this email address to my phone i was not receiving on my computer.

I am reporting the email [REDACTED] as being targeted and hacked with Malicious Activity and Fraudulent Activity and am requesting an investigation into my account.

I have once again changed my phone number and have recently removed the 2 step verification on my account to this process and am in the stages of changing the details, password, phone number, 2 step verification on my account for security purposes but wished to request an investigation into this account before i change my details

* I have attached documented evidence of the targeted malicious activity* that has been occurring for you to review part of this request to investigate this matter further.




