A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

Victims' rights: *Jane Does v. United States (2014)*

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 [REDACTED] and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add [REDACTED] (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim [REDACTED] against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

[REDACTED] v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,^[140] [REDACTED] (then known as [REDACTED]), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} [REDACTED] also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with [REDACTED]. Dershowitz took legal action over the allegations.^{[146][147][148]} [REDACTED] filed a defamation suit against Dershowitz,

Phone text message from Paul Gardner after 000 call to the Port Pirie Police Department reporting the threat of prostitution and 2 officers attending to the call in my place of residence 7 Meadow Crescent, Port Pirie - "The answers staring at you in the face"

"I use to be a conman"

"I buy phone numbers"

"I buy number plates" - Refer to document - number plate given to me by Paul Gardner, Port Germain

"I was involved in Prostitution as a child, I was born into it"

"I could get \$200.00 for you on the market" "You know, hooking"
I was disgusted by this comment and thought that Paul Gardner must have been joking as he had a immature sense of humour and walked away from him at this point - It was said to me at the Port Germain Hotel when we went out to dine. Paul Gardner said that he was only joking and apologised. - Refer to unusual comment government and prostitution making the most money from your sons / threatening behaviour

Probing the subject / suspicious

I was probing the subject of prostitution after these comments were made by Paul Gardner suspicious of his comments and whether he had been actually joking / starting to become fearful. When probed for answers Paul Gardner replied :

"I will put it to my dad" - Roger Gardner, Queensland

1 week later Paul Gardner replied:

*"Dad said yes, government approved, Howard approved it" - *John Howard*, Australian Government

One month later:

*"Your saved for prostitution by the government and I make the most money from your sons" - Attempted entrapment after this comment was made

nice to me and stated that she quite often frequented the Portside tavern, Port Pirie to have coffee weekly with her friends.

When leaving the Portside Tavern, Port Pirie I got into my vehicle and discovered that it would not start. I sighted two younger men entering the Portside Tavern, Port Pirie and I followed them into the establishment seeking assistance to start my vehicle.

The two younger men encouraged me to sit with them to have a drink while I waited for them to assist me. I sat with the two younger men in the beer garden at the Portside Tavern. One of the younger men introduced himself as "Mat" and stated that he resided in Western Australia but was in Port Pirie on holidays. (Unusual destination for tourism)
Mat proceeded to make sexual advances and became rude in nature (arrogant and aggressive)

I became defensive and stated that I did not like his behaviour, course of conversation and that I was leaving. Mat then reached across the table and grabbed my wrist and stated "Don't you want this then" and reached down to his pants and undid his zipper and exposed himself indecently. Nudity of genitals.

I became angry with him and called him a rude pig and got up to leave. Mat stood up from the table and grabbed my arm. I reached out with my other hand to slap his face to make him let me go. Mat defended himself and slammed my hand down onto the table aggressively and would not let me go before pushing me backwards. I fell to the ground.

A woman that was sitting on the other table in the beer garden jumped on top of me and was going to fight me (hurt me). I grabbed the back of her hair and the woman froze. The woman's friend yelled at me "Let her go, let her go"

I let go of the woman that was on top of me and was rushed inside to the Portside Tavern and told to get in the Taxi that was waiting for me.

That evening I took photographs of the bruising I suffered to my hands and wrists from the conflict of the attack.

Two weeks later I entered the Port Pirie Police Station to report the incident and get police assistance.

Detective Leigh Gwilym informed me that he was unable to investigate the report I made on the incident at the Portside Tavern, Port Pirie as the Security Footage was not working that day (Repeated pattern of denied security footage at the Portside Tavern, Port Pirie)

Detective Leigh Gwilym then proceeded to state two days after I reported the incident that the witness's he questioned in relation to this incident had conflicting stories to mine.

In question : Security footage was not obtained to know who was in the beer garden to question as witnesses.

I was in the beer garden not inside the establishment where the employee's of the establishment were working - no witnesses

Who did Detective Leigh Gwilym know who to question?

The only witnesses to this event were myself, Mat, his friend and the two other women sitting at the other table, not on security footage as it was not working on the day.



In March 2005, a woman contacted Florida's Palm Beach Police Department and alleged that her 14-year-old stepdaughter had been taken to Epstein's mansion by an older girl. While there, she was allegedly paid \$300 (equivalent to \$420 in 2021) to strip and massage Epstein.^[92] She had allegedly undressed, but left the encounter wearing her underwear.^[93]

Palm Beach Police began a 13-month undercover investigation of Epstein, including a search of his home.^{[71][94]} During the investigation, Palm Beach Police Chief Michael Reiter publicly accused the Palm Beach County state prosecutor, Barry Krischer, of being too lenient and called for help from the FBI.^[92]


The Federal Bureau of Investigation (FBI) then became involved. Subsequently, the police alleged that Epstein had paid several girls to perform sexual acts with him.^[89] Interviews with five alleged victims and 17 witnesses under oath, a high-school transcript and other items found in Epstein's trash and home allegedly showed that some of the girls involved were under 18, the youngest being 14, with many under 16.^{[95][96]} The police search of Epstein's home found two hidden cameras and large numbers of photos of girls throughout the house, some of whom the police had interviewed in the course of their investigation.^[93] [REDACTED] a former model from Poland who became an Epstein assistant, reportedly removed computer drives and other electronic equipment from the financier's Florida mansion before Palm Beach Police searched the home as part of their investigation.^[97] The court documents record that a search of Epstein's residence by Palm Beach Police detective Joseph Reçarey in 2005 uncovered an incriminating Amazon receipt containing books on S&M. The books he ordered are titled: *SM 101: A Realistic Introduction*, *SlaveCraft: Roadmaps for Erotic Servitude – Principles, Skills and Tools* and *Training with Miss Abernathy: A Workbook for Erotic Slaves and Their Owners.*^[98]

A former employee told the police that Epstein would receive massages three times a day.^[93] Eventually the FBI compiled reports on "34 confirmed minors" eligible for restitution (increased to 40 in the NPA) whose allegations of sexual abuse by Epstein included corroborating details.^[99] Julie Brown's 2018 exposés in the Miami Herald identified about 80 victims and located about 60 of them.^{[1][71][100]} She quotes the then police chief Reiter as saying "This was 50-something 'shes' and one 'he'—and the 'shes' all basically told the same story."^[1] Details from the investigation included allegations that 12-year-old triplets were flown in from France for Epstein's birthday, and flown back the following day after being sexually abused by the financier. It was alleged that young girls were recruited from Brazil and other South American countries, former Soviet countries, and Europe, and that Jean-Luc Brunel's "MC2" modeling agency was also supplying girls to Epstein.^{[95][101][102]}


In May 2006, Palm Beach police filed a probable cause affidavit saying that Epstein should be charged with four counts of unlawful sex with minors and one count of sexual abuse.^{[93][103]} On July 27, 2006, Epstein was arrested by the Palm Beach Police Department on state felony charges of procuring a minor for prostitution and solicitation of a prostitute. He was booked at the Palm Beach County jail and later released on a \$3,000 bond.^{[5][9][104][105]} State prosecutor Krischer later convened a Palm Beach County grand jury, which was usually only done in capital cases. Presented evidence from only two victims, the grand jury returned a single charge of felony solicitation of prostitution,^[106] to which Epstein pleaded not guilty in August 2006.^[107]

Epstein's defense lawyers included Roy Black, Gerald Lefcourt, Harvard Law School professor Alan Dershowitz, and former U.S. Solicitor General Ken Starr.^{[92][108]} Linguist Steven Pinker also assisted.^[109]







David Bradley

I met David Bradley, Tasmania / medical Industry and colleague of Vincent Bulone's at a dinner held in a restaurant accompanied by Stav, Vincent Bulone's PA (my friend) and David, Vincent Bulone's Financial officer of his research team. Upon introduction to David Bradley he asked what I do for a living (employment). I informed him that I was an Author and was in the process of completing my first book for publication. David Bradley then proceeded to ask where I came from (resided). I replied I use to live in Port Pirie but I relocated to Kadina. David Bradley then replied "You should write your book about the Red Devils (Bikie club) in Port Pirie. I had not revealed any details of the contents of my book to David Bradley or anybody else as it was under a Confidential contract with Austin Macauley Publishers, London for Copyright laws.

The content of the book does include details of bikie gangs of which David Bradley could not have known unless he had direct access to my privacy and in the privacy of my own home as that is where the book had been developed from 2013 - 2018, and installed on a computer that has not ever been connected to the internet / password protected. The only people that had access to the contents of the book was my publisher, Austin Macauley Publishers, London and myself.

During the evening while dining David Bradley informed us that he his brother was a member of The Hells Angels Bikie Club, Adelaide, who is affiliated with The Red Devils Motorcycle Club of Port Pirie, Peter Bannister.

I became suspicious of David Bradley due to the comment about the contents of the book , which he could not have possibly known or guessed and the fact that he was affiliated with The Hells Angels Motorcycle Club, Adelaide and the events of which had taken place in Port Pirie (targeting, and who was involved) - **Refer to all Files (connections)**

This alerted me to become suspicious of Vincent Bulone and his connections to the events in Port Pirie through affiliation. I started to gather information on Vincent Bulone while he was at work and questioned him constantly about suspicious behaviour, denials, replies to my questions or any strange or unusual behaviour that depicted the events of Port Pirie or my activities while in the home while he was at work and not in his presence.

Vincent Bulone spoke of an employee of the Adelaide University DVCR Mike Brooks Constantly stating that they were not just colleagues but also had a personal friendship. Vincent Bulone stated that he was going to meet him on the Adelaide foreshore on Sunday mornings regularly to discuss university matters outside of prying ears. Mike Brooks had met Tula terry, Sweden while Vincent Bulone was in a relationship with her but refused to introduce me to him or inform him of our relationship. While shopping and paying bills I was followed by an unknown man from location to location within the township of Port Pirie. The unknown man had dark wavy shoulder length hair which he wore under a blue sports cap, no writing or logo. The unknown man was of average height and build.
