Knew JE

dating someone who was very possessive around  
me being 18-19 .. Knew of JE ... but  
didn't know of abuse. didn't want me  
to be around him because he was possessive.

never told my mother what happened  
The way we had was before he  
was arrested in 2008

[REDACTED] → Shows up @ my  
house... asks my mother questions  
he gives my mom details  
my mother makes up lies to  
J.P. to distance themselves from  
the investigation. J.P. writes  
about these details as fact

My mother quotes that "Thank god [REDACTED]  
escaped" or wasn't a victim and  
her statements - not me telling her  
that - we never discussed the abuse  
That's how she dealt w/ it

My friend / Journalist I told him  
I'd been abused by J.E. but  
doesn't know details - I'm still  
friends w/ him and talk frequently  
He knows I'm talking to prosecutors  
You can speak w/ him  
Share a lot w/

Spoke w/ him <sup>about</sup> abuse; You can speak

@ 13-14 yo I was not mature looking  
@ all .. I was skinny and looked very  
young for my age ... @ 18/19 i was casted  
to play a 14 yo on TV  
I was so young looking

first experience of abuse was ~14 to  
in NY when I went to take  
Wed shots for SE -- he masturbated

was @ ~~the~~ Palm Beach Court school of arts  
then changed names to Dr. Fass  
@ this time

summer of 1997 spent in  
NY

Maxwell generally present between 24<sup>th</sup> - 27<sup>th</sup> etc

They both tried to groom me + make me  
feel safe -- I was never really  
sure what their relationship was...


She would talk about BF's w/ me --  
take me shopping -- to movies  
she would normalize things for me...  
"This is what grown ups do"  
If you want to get ahead

fairly early on GM "join in"  
and started taking her clothes off  
about 6 months into it this started  
- I was still 14 yo

Not a specific memory of the first  
time..

when GB would "join in"  
JE would tell someone..  
a girl/girls to massage him

Initially it was just NB alone w/ JE  
he would want to shower..  
Then as to to rub his  
feet or help after the



@ first I could leave my underwear on  
but then it progressed

Maxwell started participating in  
the first massages

-That's how she started

I had a hard time looking @  
her during these encounters

\* She would usually be topless and  
keep her thong on - She would  
be chatty and be coaching other  
girls what to do.

I don't have recollection - NOT  
sure if she touched me during  
these encounters - She did touch  
other girls - possibly kissing + touching them

as abuse got worse w/ SE I felt as  
though there were less + less people  
around - GM was not around as much  
and became more 1 on 1 to make  
me feel special..



SE, GM and me would be just somewhat  
hanging out and I would be directed  
to massage him or Belva when alone  
would stand

abuse happened

was always  
a massage  
table involved

PL Pool house / Bedroom

→ NI Bedroom / massage Rm

↘ NM Bedroom / massage Rm

JE's assistant

my brother just recently talked to  
talked about case she was emotional he  
says this ruin her life  
was involved in abuse but was only  
2 years older than me

JE had a god complex, feel as though  
his victims had a class system

was involved in the abuse

Maxwell was still participating in set out when  
I was 17 to

18, 19, 20 I didn't see GM as much

There was no hard cut off for  
GM's participation

She <sup>GM</sup> participated in FC, NY + NM  
all ~~of~~ between 14-17 50

She was present + participated about 25%  
of the  
time

If she didn't always participate if she  
wasn't in house, or maybe  
if JE didn't want her involved  
at that time

was ~~not~~ GM present ~~if~~ when JE  
used a vibrator?

was present for other acts by JE? <sup>Not sure</sup>

not sure

Was GM present for everyone being  
naked + JE touching you?  
Yes

Recall

GM talking out set acts?  
Not sure

She would talk about her other  
BF's more... not as much JE

Not sure if she talked about how  
he liked to be massaged

JE was normally the one directing the  
whole encounter so she fell to  
the sidelines a bit... I just kept  
my head down hoped they would focus  
on someone else more

GM talked about the encounter after  
the fact?

not sure... not much discussion

Not much feel back after... but I  
had been fat shamed by him @  
around 16 yo he would take  
Polaroids of me in underwear and  
tell me my ass looks big...  
he wanted me to wear white cotton  
underwear + Bras... GM + JE would  
tease me to VS about 2 times

to buy these...

They would take me shopping  
to buy pretty clothes

GM did not take photos of me  
& wasn't around for the photos being  
taken

was less abuse if he had a lot  
of friends around

I was not asked to be passed  
around to other persons and did  
not have an idea that others were

Summer of me 16/17 I stayed in  
NY and I would stay  
in one of his apartments  
sometimes w/ my mother --  
Sometimes I stayed @ his house  
Sometimes if I stayed in the apt. I  
wouldn't see and it was a relief

There was times I was not abused and  
just brought over to be "shown off"  
one time to mitie walkie - to say  
happy birthday

The dean of Interlochen was there  
one time for a cocktail party I  
met him through JE  
also dean of admissions for Guilford

Adam Perry was one of his private chefs  
in NY, but did travel w/ him  
once to NM I was w/ him

don't recall Henry Gmt JE Henry <sup>sexual</sup> conversations  
of about abuse  
orgies

during encounter she  
would massage, or rub bodies  
not totally sure

She gave me a big sister vibe  
that it made me uncomfortable to watch  
her so I tried not to look  
so she may have been active w/  
other girls

if it was just we Gmt J&E I was  
wade to do more sexually

Gun present for oral sex incidents

Possibly in my on message table

girl there -  
he makes her sit on top  
possibly <sup>and</sup> massage of him and has sex w/  
him

Short blonde hair pretty -  
maybe [REDACTED]

a couple of times he had sex w/ other  
girls in context of marriage -  
that she witnessed

sometimes around 5 times  
he would pull them onto him and  
have sex w/ them.

all model looking

~~one~~

matwell would not be surprised when  
J&E would have sex w/ the girls  
almost no restraint

The orgies would occur in the  
massage room typically ... some  
recollection of this happening in bed  
w/ maybe in 2 other girls ...  
many of the interactions w/ just one + JF  
were in his bed.

oral sex w/ others on JF was more  
common to happen than sex  
\* G.M. was probably not present for  
times JF had [redacted]  
on him ... but she would have  
been present for other [redacted]  
[redacted]  
G.M. would have no reaction ...

no one acted after the fact as though  
this was not appropriate ...

<sup>in my</sup> one girl who cried when called into  
the massage room because she  
had a BF and felt she  
didn't want to do this anymore  
other girls said its ok and she can  
stay back - he won't notice

Pool house in FC ... Futon/couch  
Kitchenette  
TV... Shower

Abuse happened in there on couch

JE <sup>uses</sup> vibrator or sex toy <sup>on</sup> <sup>NB</sup> around GM?  
don't recall but possibly

Generally while he was

he would

\* GM would be unbelievably casual about  
the experiences

So in NY if I didn't stay w/  
I would stay mostly in JE's apt--  
My cell would call me -- or JE,  
or JE's secretary... It was sometimes  
an order less than a request  
and a Ticket would be delivered to us  
door

early on GM coordinated most  
of the travel... she would call  
Booked flight

GM came to the gate in NY (prior to 9/11)  
his driver would take me to and from airport

on one occasion TO talks to flight  
attendants to get me on plane  
because I didn't have photo ID  
I was 16

calls went through either me or my mom  
mother would tell me to be respectful...  
few occasions both of my brothers  
answered the phone when JE called

would get call stating when we are  
planning on leaving - either Jet or private  
was primarily on his Jet in the beginning  
possibly flew continental airline

About a hundred of times I flew on his  
Jet  
Typically didn't miss much school to travel  
to see him usually weekends  
or holidays I traveled

GM would normally be on the jet w/  
me but not always ...

when we flew together from FL to NY  
w/ GM + JE... sexual abuse  
would then occur after  
the fact @ some point  
in NY during that trip

anytime I came to NY it was  
in connection to being w/ GM + JE

Travel

Remember talking to GM about using Jet + Commercial.

Jet... I just needed an ... needed name &  
Private... weight

He would send a car + a driver that worked  
@ his house (Latin American guy)  
his wife also worked  
in house... maybe it  
was Mario + Maria

I would get picked up... driven to JE's house  
Then we all go to airport together  
for Jet

Commercially I went by myself in car  
JE's Driver ..

Tickets were sent to my house  
via messenger service in NY  
or his driver in FL would  
drop to me

Could have been the driver who picked  
me up to bring me to airport  
who had ticket

after meeting him ... was quickly to be brought  
to NY ... I was still 14 when it started

GM was present in Rm when  
JE was masturbating ... I'm confident  
of that ... and he was  
likely touching other women @ that  
time

Massage therapist in FL - he occurring  
she was ~~to~~ pretty, long hair but  
not smart

Possibly named [REDACTED]  
sexually abusive
