NOMINATIVE, INDIVIDUAL AND CAN NOT BE TRANSFERRED TO THIRD PARTIES
Only for the designated train, date, class and designated route.

To be valid, the electronic ticket confirmation should be:

- accompanied by a valid identity card with photo⁽²⁾.
- presented when boarding the train and during ticket control.
- Printed on white A4 or US letter paper, without changing the print size. A good quality printing is required.
- the ticket can be re-printed at the train station.

To ensure timely departure of TGV and Intercite's we ask you to arrive at the indicated departure platform at least 2 minutes prior to departure time. Access to the train may be denied if you arrive later.

We remind you that it is obligatory to label your luggage.
