Proceeds shall be allocated by the following formula:

- 1. Individuals and non-multicandidate PACs - The first \$2,500 will go to RFP's primary account. The next \$2,500 will go to RFP's general account. The next \$30,800 will go to the RNC. The remaining amount will be split evenly between the NRSC and NRCC, up to a maximum of \$20,000 per committee.
2. Multicandidate PACs - The first \$5,000 will go to RFP's primary account. The next \$5,000 will go to RFP's general account. The next \$15,000 will go to the RNC. The remaining amount will be split evenly between the NRSC and NRCC, up to a maximum of \$15,000 per committee.

Notwithstanding this allocation formula, a contributor may designate a contribution for a specific participant or participants.
