<ol style="list-style-type: none"> Prepaid U.S. Dollar Rates are strictly non-discountable and cannot be combined with any other promotional offer. Rates exclude items shown above and optional refueling or additional services such as child seats, additional driver fees, luggage racks or one-way charges for which the renter may be responsible. Excluded services cannot be prepaid. If accepted, must be paid locally at time of rental in local currency. In some countries, a non-waivable amount may apply if the car is stolen or damaged during an attempted theft or vandalism. Also, in some countries, a non-waivable amount may apply if the car causes or contributes to an accident. Any changes to the reservation may impact the rental charges and require that a new voucher be issued. Changes requiring the re-issuance of a faxed voucher must be made at least 8 hours prior to departure from the U.S. Changes requiring the reissue of a mailed voucher must be made at least 14 days prior to departure from the U.S. mailing address. There are no administrative charges for changes to the voucher. Cancellations will be accepted for a refund up to 34 hours in advance of pick up without penalty. A cancellation fee may be applied if reservation is cancelled less than 34 hours in advance of pick up on bookings for Latin America, Mexico, and Caribbean destinations. Refunds can be issued on unused voucher portions when a three rental day minimum is met. Voucher is non-transferable. No credit will be issued until the voucher has been returned to Hertz. After the rental date, no credit will be given on unused vouchers or unused portions of vouchers. Minimum rental age varies from country to country and may also vary by car group. Driving restrictions vary from country to country and may also vary by car group. (Please check with your travel consultant or Hertz for specifics.) Standard rental qualifications and rental period restrictions apply. All drivers must have a valid driver's license in effect for at least one year prior to rental date and present it to Hertz at the commencement of the rental. An International Driving Permit may also be required. A valid credit card or Hertz Cash Deposit identification card which will require leaving a deposit must be presented at the time of rental to cover any reasonably anticipated charges which have not been included in the prepaid voucher. All rentals are subject to Hertz standard terms & conditions of the Hertz Rental Agreement in effect at time and place of rental. Only a car class/group is confirmed. Specific make/model preferences are subject to availability at time of rental. Rental days are based on 24 hours periods commencing at time of pick up. Additional days will apply if rental is kept longer than specified. (Additional days begin after 29 minute grace period and will be billed at a higher rate.) This program is available at participating cities/locations. Third party liability insurance coverage equal to the applicable state minimum limits is included. Secondary, where applicable. Voluntary upgrades will be charged at locally applicable rates.
