Passport

You must provide your actual *signed* passport, including one copy of the personal information page of your passport. Your passport must:

- Have at least two consecutive blank visa pages
- Be valid for six months beyond the validity of your requested visa

Photographs

You must provide two color, passport-type photographs that meet the requirements outlined by the Russian Ministry of Foreign Affairs. Your photographs must:

- Be printed on photo paper
- Have a white background
- Be 35mm by 45mm
- Have been taken within the last six months
- Show the full frontal view of your head, including the tops of your shoulders
- Have your face centered in the middle of the photo with your face square to the camera
- Display your face with a neutral expression and your mouth closed (no smiling)
- Not display sunglasses



Russian Tourist Visa Support Letter

You must obtain an official Russian Tourist Visa Support Letter to travel to Russia. CIBTvisas can obtain a Russian Tourist Visa Support Letter on your behalf. Consult the complete application kit to obtain the forms and instructions for this service.

You Need To Fill Out:**Russian Visa Application Form**

The Russian Consulate requires a visa application be completed online by all travelers, and can be found at <https://visa.kdmid.ru/>. This application, hosted by the Russian government, may take up to an hour to complete and requires very detailed information. For Houston visa issuing office, select "Visa Application Center ILS (Houston)" in the drop down box. Your visa request cannot be processed if you do not complete the application form online. Your completed application must:

- Provide answers for all fields (handwritten changes are not accepted)
- Include your name as it appears in your passport
- Include the institution or organization in Russia to be visited
- Be signed inside the box found directly below the section where we will attach your photograph. Your signature must match the signature in your signed passport
- Be accompanied by a copy of your Application ID and password

A correctly printed application must be printed so that the distance between the borders and the edge of the paper should be no larger than 7mm. The border of the application must also go all the way around the paper. To ensure that the form is printed as above, please make sure your printer settings are set as follows:

- Page Scaling should be set to: None
- Auto-Rotate and Center box: Not checked (left blank)

**Russian Consulate Supplementary Form**

You must provide one completed supplementary form found in this application kit. This form must be signed in blue or black ink and copies are not acceptable.

**CIBTvisas Order Form**

You must provide one completed CIBTvisas Order Form. The form must:

- Include a valid email address and payment information, if applicable
- Include your signature in blue or black ink

**Optional Form-Fill Service**

The Russian Consulate requires a visa application completed online. CIBTvisas offers an easier solution to our clients: the visa application questionnaire included in this kit. This May Pertain To You:**Former Russian Nationals Only**

You must provide a cover letter stating the date that you renounced your Russian citizenship. The consulate will not issue a visa to former Russian nationals who do not supply this cover letter.

**Minors Traveling to Russia**

All minors must submit a copy of his or her birth certificate. Other conditions may apply:

- If the minor is traveling to Russia with only one parent or without both parents he or she must submit a notarized original letter of consent providing permission from the non-accompanying parent or legal guardian to travel to Russia on the specified dates of the trip. Those signing this letter must provide copies of his or her driver's license and passport information page
- If the minor is adopted then you must submit a copy of the adoption papers in addition to a copy of the birth certificate
- If the parents already hold a Russian visa then they must provide a copy of the Russian visa showing validity that covers the minor's travel dates
- If the parents are Russian citizens they must provide certification of Russian citizenship

**Activities in Russia**

If you will not be staying in a hotel, or are engaging in activities other than business, additional documentation will be required. For more details, please contact CIBTvisas for more information.

**Former Soviet and Ukrainian Citizens**

If you were born in a state of the former Soviet Republic or Ukraine, you must supply a copy of your Soviet or Ukrainian passport along with a letter stating when you immigrated to the US.

**Former & Dual Russian Citizens**

If you were born and left Russia before 1991 you must submit the proof that you have left before 1991 by providing your former USSR passport with exit visas and your US Naturalization Certificate. If you left Russia after 1991, you are still considered a Russian citizen hence, you must travel with both your US and Russian passports. If you prefer to renounce your Russian citizenship you must appear at the Consulate in person.

Special Eligibility Visa

The Russian Federation offers US nationals the opportunity to apply for a three year multiple entry visa. To be eligible for consideration, the traveler must have a passport valid for at least three and a half years beyond date of first entry into Russia with at least two blank pages.

Applicants should expect to submit further documentation. Processing time is a minimum of 15 days. For further information about how to apply for this visa contact a CIBT Customer Care Specialist.

Consular Fees:

In addition to CIBTvisas's service fees, consular processing fees are included in the cost of your visa application. The consulate fees are inclusive of a visa application fee when applicable. CIBTvisas submits payment for your application to the appropriate consulate on your behalf. A 5.7% processing fee is assessed on government fees when they are paid by CIBTvisas. - Allow approximately 30-45 minutes to complete the application
- It is recommended that you examine this guide in its entirety before beginning the Russia Tourist Visa Application Form. Ensure that you possess the information and documents required to complete the application
- It is recommended that you click the "SAVE DRAFT" button before moving on to each new screen during your application process
- You will be able to save and edit your application if you do not complete it in one sitting or if you make an error:
 - To return to or to edit a saved application you will need your numeric Application ID, the password you set up at the onset of the process, your date of birth and the first five letters of your surname.
 - To retrieve or to edit a saved application return to the main Russia Visa Application website, <https://visa.kdmid.ru/>, and click the button:



When you have completed the Russian Tourist Visa Application Form, you will send to us:

- The final printed Russian Tourist Visa Application, including your original signature and the date, with the required documents listed in our Application Kit. Photocopies of your signature will not be accepted
- The printed copy of the Application ID screen. Write on this paper the password that you chose as well as your answer. This information is essential if changes are required to complete your application. Changes are very common. Be aware that we will be required to call you should you forget to include this information resulting in a slower application process.






