

Schedule 3: Automatic Payment Authorization

By signing this Automatic Payment Authorization below, you hereby authorize California Cryobank, LLC ("Cryobank") to automatically charge the credit card that you have provided the Monthly Storage Fee for those services provided to you pursuant to the Specimen Storage Agreement (Acct. No: _____) (the "Agreement"). A summary of certain terms and conditions is set out below. Please see the Agreement for more information.

- 1. What is the Automatic Payment? Cryobank will automatically charge the credit card that you have provided on a monthly basis the then-current Monthly Storage Fee. The Monthly Storage Fee is charged in advance for those services that Cryobank provides to you relating to the storage of your specimens.
2. When the Automatic Payments Begin. The automatic payment of Monthly Storage Fees will begin in one of two ways: (1) if you have pre-paid for storage, the automatic monthly payment will begin on the conclusion of the Pre-paid Storage Period, and (2) if you have not pre-paid for storage, the automatic monthly payment will begin upon the execution of the Agreement.
3. The Monthly Storage Fee; Amount and Changes. Cryobank will automatically charge your credit card the Monthly Storage Fee that it generally charges to its other customers. Cryobank reserves the right to change the Monthly Storage Fee at any time. If Cryobank changes the Monthly Storage Fee, it will send you written notice via regular mail and email approximately thirty (30) days in advance of the change.
4. How Long the Automatic Payments Continue. The automatic payment of the Monthly Storage Fee will continue monthly until you either terminate the Agreement or enroll/re-enroll in the pre-paid storage option.
5. How to Cancel Automatic Payments by Terminating the Agreement. The Agreement sets out how it can be terminated. Please note that, to terminate the Agreement you must submit the Specimen Storage Discontinuation Form (the "Discontinuation Form") pursuant to the instructions included in the Discontinuation Form. You can request the Discontinuation Form by calling Cryobank's corporate headquarters via telephone at 866-927-9622, or by requesting a copy of it via email at by contacting the Cryobank at _____ or in person at any of the Cryobank locations.
6. How to Suspend Automatic Payments by Enrolling in Pre-Paid Storage. You can suspend the automatic payment option by enrolling/e-enrolling in the pre-paid storage option. You can enroll or reenroll in the pre-paid storage option by contacting the Cryobank at _____. Please note that, once the new Pre-paid Storage Period ends, Cryobank will resume the automatic payments as set out in No. 2 above.
7. Your Obligations. You acknowledge and agree that: (1) you will notify Cryobank in writing of any changes to your billing information at least thirty (30) days prior to the next billing date, and (2) you are the authorized user of the provided credit card.
