Charter Agreement Terms and Conditions

Cancellation. If transportation is canceled pursuant to this subsection, Client shall pay the following amount to MAC: 2.0 hours at the hourly charter rate if canceled less than 24 hours from the originally scheduled departure time for domestic flights and if canceled less than 48 hours from the originally scheduled departure time for international flights. Any expenses incurred by MAC in arranging this trip will also be paid by the client as part of the cancellation charge. The date and time of the intended flight departure shall be used for calculating how long in advance cancellation occurred. Said amount is not to be deemed a penalty, but rather shall be paid to MAC for MAC's actual expense and damage caused by cancellation. Client shall indemnify MAC for all claims whatsoever put forward by passengers, shippers or other persons in connection with cancellation on the part of either Client or MAC.

Meridian Air Charter must receive payment in full for all anticipated charges prior to origination of the charter. Meridian Air Charter will accept the following methods of payment:

- Bank of America customers-via online transfer; or
- Wire transfer in accordance with the wire transfer instructions noted below and in Charter Agreement; or
- Credit card charges which shall include a three (3%) percent processing fee.

All Funds must be payable in US dollars and must clear Meridian Air Charter's bank account before the aircraft is dispatched. In addition, a credit card shall be provided, or other arrangements made, by Client for any additional charges incurred beyond those paid for in accordance with the payment procedures herein. Upon completion of the charter, MAC shall invoice Client for all actual charges, expenses and advances. Payment shall be due upon presentation of invoice without deduction or setoff except for any amount previously paid for anticipated charges. Should such invoice not be paid upon receipt, MAC will automatically, and without further notice, charge client provided credit card, the balance together with the three (3%) percent processing fee.
