sooo, I've been thinking on this....this ticket you found has [REDACTED] returning on the 5th back to Rome (when she needs to go back to London on the 4th for school) We could book this below ticket (for \$538.36) then after her departure on 28th cancel the return part of her ticket and purchase the Norwegian Air Shuttle flight NY to London on 4th for \$281.99 (although price could change by Jan. 29th...) We can't purchase the REAL return until after she has departed on the 28th because the airlines could possibly cancel one or both return flights if we book before her departure. The round trip ticket (Rome/NY/Rome) at \$538.36 is much lower than trying to book her through to London for thousands. I have spoken with my Amex rep and she thinks all this would work.
