Also, in the event he declines to be interviewed, please ask him to answer the following questions in writing. He should feel free to elaborate in any way he see fits.

Here are my questions.

2. Does Mr. Dershowitz still act as your lawyer? If so, in what capacity? Do you still compensate him for his legal services? If not when was the last time that you compensated him for his legal services?

5. It is my understanding that you meet socially or provide financial or philanthropic advice to a number of people. I have been told those people include, among others, Bill Gates, Woody Allen and Ehud Barack. Is that the case?
