I ordered an iPhone with a wireless account. Who can pick it up?

What if I chose to have my iPhone delivered?

If you've ordered an iPhone with a new line, the primary account holder on your wireless plan must pick it up. The primary account holder is the person whose billing information is linked to the wireless plan.

If the iPhone is an upgrade for an existing wireless account, it can be picked up by the account holder or by a person authorized by them. Contact your wireless carrier to authorize people on the account.

If your iPhone is unlocked, it can be picked up by the person who placed the order or the pickup contact on the order. For more information, visit [How to Pick Up Your iPhone](#).

How do I recycle my old phone?

You can recycle your old cell phone for free with the [Apple Recycling Program](#).

Once you have your iPhone, activation is simple. Turn on your iPhone by pressing and holding the On/Off button for a few seconds. Then follow the onscreen instructions to set it up.
