**OUTLINE OF PROCESS**

**Preparation Call**

Your personal phone bidding agent will call you the day of, or the day prior to your lots coming up for auction. They will go over all the lots you will be bidding on and tell you what the opening price will be. At this point, you can decide whether or not you want to proceed with the live floor bidding for each lot.

**Live Auction Call**

Your personal phone bidding agent will call you approximately 5 minutes before your lots come up for auction. Since we cannot guarantee how fast the auction will go, you need to be available to receive the call at least an hour before the scheduled call time (we prefer that you are available from the scheduled start time of that session) with a list of lots and descriptions.

**Bidding Overview**

When your lots come up for auction, your personal bidding agent will call out the lot number and opening bid. The bidding will be moving very fast at this time, and you will need to immediately confirm whether or not you will bid the next increment. A table of bid increments is provided below for your convenience. You may only place one cut bid per lot.
