1. Medical.

We have a situation.

[REDACTED] has had a sinus condition for a few months, like a constant cold, with discomfort in her face. She went to an Ear, Nose, Throat doctor, David Edelstein (<http://www.davidedelsteinmd.com>), who prescribed a course of antibiotics, which didn't help. Then a course of Cipro (which is used in these cases) which also didn't help. Next he did a catscan on her nose, and based on the results scheduled her for a procedure which he said was one he's done 5,000 times and it's to drain the sinuses.

[REDACTED] who gets nervous about such things, postponed it as we have trips planned, saying she wanted to see if it was getting better on its own, without the procedure. Edelstein then called her and said it's a necessity because he needs to check for a tumor. And this time around, rather than describing it as a simple daring procedure, he said it's surgery (she would go in at 6am and be home the same day). [REDACTED] asked what are the chances it may be a tumor and he said 1 in 10,000.

Our internist, who was a major player in his day (Jackie O, Pavarotti, Dan Rather) is now 84, mostly retired, and can't really advise or get involved.

We need (a) advice on the above about questions to ask or second opinion and (b) to get set up with an internist who has his act together and is up to speed on the latest in medicine and can act as the traffic cop for this kind of thing.

One thing our internist did tell [REDACTED] was to go see Edelstein for a face to face and ask him questions, but then, what are the questions??

Any advice, let me know. We'll be back in NYC 5m on [REDACTED], or office tomorrow [REDACTED]. [REDACTED] private email is [REDACTED].
