Please find below the mail I received today from Me Guyot, stating:

*"As you are probably aware of, the court hearing in the proceeding has been postponed to August 5, 2013.*

*Therefore, in order to achieve a project by this date, the American counsel of my client requests that the parties comply with the following calendar:*

- *Before June 18, 2013: determination by Mr EPSTEIN of the project expected from Mr FANCELLI (cf. my previous email);*
- *Before June 21, 2013: agreement on a first draft protocol in English and French versions acknowledged by our respective clients;*

*Could you please contact the American counsel of your own client?"*
