Thanks for the revised certificate. Here are **approximate quotes** based on the completed value of \$1,900,000 with deductible options:

\$2500 deductible would be approximately \$9513; \$5000 deductible would be approximately \$7139; \$10k deductible would be approximately \$5946.

The liability would remain on your current policy but the physical damage for the dwelling will be the above builders risk.
