So, I have revised the menu below, but also took the liberty of including a few a la carte menu selections that I think would make good additions to the spread. Beth confirmed that we can add whatever we like - this will simply be included in our overall bill at pricing listed on the menu.

Right now, we are looking at a food total of **\$1109.36** - including a la carte options and even dessert (if desired), but excluding bar tab:

8 apps for \$30pp for 2 hours x 22 people = \$660
A la carte selections = \$218
FOOD Subtotal = \$878
+ Tax (6.35%) = \$55.76
+ Gratuity (20%) = \$175.60
TOTAL = \$1109.36 (not including bar tab)
