## Outreach in Europe

The HRADF has a window of opportunity to engage in Europe to cultivate allies and condition negotiating positions with a new Greek government after June 17.

Given the urgency of securing a very high level of political awareness of the fund and its role, and the limited time, we believe the best focus is on key decision makers in Brussels, London, Berlin and Paris who will carry the most weight in negotiations around and after June 17. We also believe that the ECB and the Bundesbank in particular need to be made aware of your work.

In most of these cases we have networks that will help us secure meetings with you or for you. We can draw up a much wider parallel list of contacts who we would seek to brief on your behalf, using the European Stakeholders presentation

and the Portfolio Overview. We also have contacts at the World Bank and IMF who can be briefed.

We would recommend a strategy that seeks to establish links with as many as possible of:
