Terms & Conditions:

1. Welcome bonus of 10,000 TrueBlue points will be awarded to Basic Cardmembers 6–8 weeks after the first purchase on the JetBlue Card from American Express. This offer is valid for first-time JetBlue Cardmembers only. First purchase offer expires one year from time of Card account opening. You may be permitted to have more than one JetBlue Card account; however, you are only eligible to receive one welcome bonus.
2. You will earn an additional 10,000 TrueBlue points if you apply by April 1, 2011 and use your JetBlue Card to complete \$500 of eligible spending by the end of your first three months of Cardmembership, based on the date of your Card approval. TrueBlue points will be credited to your account 6 to 8 weeks after you reach the spend threshold. If your application is received after April 1, 2011, you will not earn the additional 10,000 points.
3. Certain flights require more points to redeem award travel based on flight chosen and peak travel periods.
