Earlier this week we announced that we entered into a partnership with Deutsche Börse, one of the largest exchanges in the world. Deutsche Börse has made a \$10mm investment in Trumid and will join our Board of Directors (amended LLC attached). More importantly, we are creating a JV to develop and operate a trading platform in Europe which will be built upon Trumid's technology.
