I spoke to Alina today. She reviewed the documents and said that everything looks good. The most important thing is the invitation letter and to make sure that name, passport number, etc is all the same between passport and the letter. (Must match)

She said she understands that Jeffrey has had 4 Russian Visas before and the application form shows only 1 travel to Russia. If we can get a hold of his old passport (if he still has it) and remove 2 or 3 France travels and include 2 or 3 more Russian travels, that would be better.

We cannot do expedited/same day service since it is a double entry visa. That only applies to single entry visas, therefore, 10 business days is the only way we can go.
