the box for the chairs are 3" inches to tall and 1" too wide for the international Package service to St. Thomas.

Fedex will only take the box size by Freight

Box Size Each :23" x 22" x 35"H 24 lbs

The only way they can be shipped is by Fedex Freight. However the price is outrageous.

Fedex Standard Air: \$765.00

FedEx Freight : \$1894.73

We can ship the items to Florida to a forwarding agent that can send them by sea if you know what agent works for St. Thomas.
