Perfect. Karyna, do you want to wait until you and [REDACTED] are on site to arrange for Brandon&Transfer to review the furniture coming to STT?

Also, did Mr. E give you a timeline for when he would like this furniture on LSJ?

The furniture itself is on site, the cushions will be completed this weekend, Janusz will pick up next week.

I would respectfully suggest 12/31 or 1/2/15 for delivery by Brandon&Transfer to Tropical FL - that gives us time for you and [REDACTED] to review the furniture, Janusz to collect the cushions, hire Brandon&Transfer to review and provide the quote for the packing and delivery, and pack and deliver the furniture to Tropical FL.

If the furniture is delivered 12/31, we can sail 1/2/15, EDA to STT 1/6/2015.

If the furniture is delivered 1/2/15, we can sail 1/7/15, EDA to STT 1/10/15.

These are tentative schedules, trying to factor in the Holiday restrictions.
