#### RESCHEDULE / CANCEL POLICY

If you reschedule/cancel your testing appointment 31 business days or more in advance you will incur a \$25 rescheduling/cancel fee. If you reschedule/cancel your testing appointment between 6 and 30 business days before the test date you will incur a \$60 rescheduling/cancel fee. If you reschedule/cancel your testing appointment between 1 and 5 business days before your test date you will incur a \$100 rescheduling/cancel fee. Testing appointments rescheduled/canceled the same day as test date, failure to appear for a scheduled test or presenting himself/herself more than thirty minutes after the scheduled start time for taking the test will result in a forfeiture of all testing fees and you must submit a new application to test.

#### DRIVING DIRECTIONS

One block east of Grand Central Station. The northeast corner of Third Avenue at 42nd Street.

\*Please be advised, that it is prohibited to bring food or beverages into the testing center and in some cases into the building where your test center is located. Please be advised that due to these restrictions, you will need to make other meal accommodations for your test day.

#### ADDITIONAL INFORMATION

You will receive a confirmation email for each day of testing.

Important Note: Previously two erasable note boards, two low-odor fine tip dry erase markers, and an eraser were provided to you by test center staff for your examination. However, sites are in the process of receiving new markers. These new markers are of better quality but they cannot be erased with an eraser. Therefore, sites will not be supplying you with an eraser. If you fill the two note boards and require additional note boards, please raise your hand and inform the test center administrator. The test center administrator will exchange one of your used note boards with a new note board. This change has not occurred at all sites yet but will be implemented within the next few months.
