Thank you for your presentation.

I understand you have put a lot of work into it, however I would need to ask you to start over please keeping in mind the ideas mentioned below.

As we have discussed earlier, the overall esthetic of the rooms should feel more contemporary, and light. Soft white/off white tones should be predominant.

We would like to have a larger rug, covering most of the floor area. In terms of the furniture and accessories presented, the style of the white chase lounge (item#4) is in the right direction, however the rest will need to be changed. In regards to the storage furniture, please keep in mind there should be space for hanging clothes, shelves or drawers for folded clothes, socks and underwear, space for shoes and luggage.

I have attached below an image as one of the inspirations for the colors. A bit more modern version of that would be nice. We also liked many images of the Soori resort that you presented at the beginning.
