In complement to my mail dated June 15<sup>th</sup>:

the **AZURRE quote** relates to a renovation:

it includes 3 windows in one bedroom and one in a small cabinet room (WC).

for a total amount VAT included of 15,740.89 €.

NB: compare to the other quote below, it will probably need less interior building work, but painting work is likely to be the same for matching colours throughout the room concerned.

the **WINDOFF quote** concerns the installation of new windows frame:

it includes 3 windows in one bedroom/bathroom and one in a small cabinet room (WC).

the total amount does not include the option for special reinforced glass (for sound and heat) which amounts to 915,00 + VAT = 979.05 € to be added.
