**CHAPTER 11 TRUSTEE HERBERT STETTIN'S SECOND AMENDED¹
CROSS-NOTICE OF RULE 7030 EXAMINATION OF JOHN (JACK) SCAROLA**

Herbert Stettin, Chapter 11 Trustee (the "Trustee") of Rothstein Rosenfeldt Adler, P.A.
