The Limited Partner makes such revocation, withdrawal and rescission notwithstanding the facts that (1) the Request stated that the Request was unconditional and (2) the Request stated that the Request was irrevocable.

The Limited Partner hereby reaffirms its agreement to the Second Amended and Restated Agreement of Limited Partnership dated May 27, 2005 of the Partnership (the "Partnership Agreement") and its subscription agreement(s) with the Partnership, and the Limited Partner understands that any future request the Limited Partner may make for a withdrawal from its Capital Account will be subject to all the terms of the Partnership Agreement and such subscription agreement(s), without regard to the Request.
