An impressive 4th floor loft apartment of c.220 sqm with tower room offering 360 degree views of Florence and the surrounding hills. The accommodation provides a grand reception room with dining and living area round an open stone fireplace and an open plan, fully equipped kitchen with a separate laundry/storage room. The entrance hall with a guest WC leads to the master bedroom with en suite bathroom and stairs, which lead to the panoramic tower with shower and WC: an ideal studio or guest room.





The apartment has full air-conditioning, underfloor heating and cooling, and is accessed with a glass panelled lift.



This 15th Century Palazzo features a principal courtyard designed by Brunelleschi, creator of the magnificent dome of Florence's cathedral, and belonged to several important Florentine families.

Palazzo Bardi has undergone an extensive restoration to transform it to its former glory. Many of the original features have been carefully restored to create a stunning combination of modern living in an elegant historical building.
