

Dear Nikolai,

Following our earlier discussion today I would like to outline some key points.

Due to a counter offer on the GTSL exit project all corporate blocks i.e. 100,000 shares have an adjusted value calculated at €1,300,000.

As you are aware the buyer's bank requested a 5% assurance bond prior to the completion of the exit procedure. This requirement has been secured on the previous exit value at €32,500 as allocated on the 26<sup>th</sup> July 2010.

The buyer has matched the counter offer and GTSL have agreed not to consider any further offers for a period of 10 days this agreement was initiated yesterday giving a deadline of the 24<sup>th</sup> September 2010.

Taking into account the new exit value the 5% bond requirement has a costing of €65,000. With the previous bond secured an adjustment of 2.5% is required to enable an exit at the new value.

This would require a bond adjustment requirement of €32,500 with no commission attached.

All positions are required to meet this adjustment and the buyer's bank have agreed not to adjust the bond any further regardless of counter offers at any value.

With these precautions taken into account and a counter offer restriction in place until the 24<sup>th</sup> September 2010, the project can complete the exit process at the end of September 2010.

I will speak with you again on Friday to discuss this final requirement further.
