Dear Richard,

Following our discussion, enclosed please find the contract with the required modifications.
I have the following comments:

section 5.4 - after discussing with our lawyer, I think it would be more reasonable if you carried out the technical inspection of final product here in the factory, and upon this transfer the second payment (before shipment).

Either you may come yourself (you are very welcome, plane tickets to Poland with return to NY is \$ 1-2 k) or entitle someone to do it for you.

We can also arrange an inspector of Germanischer Lloyd or other class. society, and even cover the costs.

Finally we can entitle somebody to be present during the loading the boat on the ship.

However what we would highly require is payment before shipment.

section 6.1 - we picked British law. Can be Spanish or Portuguese - better geographically, however I don't know if this is on the same arbitration level as German, British, Austrian.

I will give you a call ca. 10 NY EST to discuss.
