The HLX8 is a quantum leap in technology for the treatment of many medical ailments afflicting people all over the world. 
WHAT IS THE HLX8?

The HLX8 is breakthrough technology for the treatment of many different ailments that afflict both humans and animals. Although the HLX8 design incorporates magnets it is not a magnetic therapy device. The HLX8 incorporates a unique magnetic array that spins at high rotational speeds to produce a tornado like field of structured ions.

This is an illustration of the field emitted by the HLX8



This field of ions then affects the low level electromagnetic charges that are around each cell in both humans and animals. When these charges around each

cell are properly polarized the cells are forced into the optimum position and alignment for health and life. Unhealthy or cancerous cells cannot exist in this alignment and therefore die.

This illustration shows the regular structure of normal cells versus the irregular structure of cancer cells.



As the body is exposed to the field emitted from the HLX8 good cells become even stronger and healthier whereas bad cells die. These dead cells are then eliminated from the body by the natural bodily functions that handle dead cells. Someone with cancer must use the HLX8 at a rate that matches what their normal bodily functions can handle as the dead cancer cells are released in to their bloodstream. For the typical person with cancer they should use the HLX8 for a maximum of one hour per day to avoid overloading their liver and kidneys with dead cancer cells that are being removed from the body. 

Production models of the HLX8 will be produced in operational voltages and frequencies to match the different electrical power systems for the various countries that they are to be sold in. Component parts for the HLX8 will initially be supplied from different suppliers around the globe with final assembly taking place in the United States. The magnetic array will only be produced in the United States at our in-house facilities in the Los Angeles area both for quality control and secrecy reasons. Later the final assembly of the HLX8 may be located in various locations around the world to minimize shipping and production costs as well as providing product support on a global basis.

THE STORY BEHIND THE HLX8

My name is David LaPoint and I am a 51 year old engineer/inventor/physicist from Huntington Beach, California. I have over 30 years of experience designing and building very complex high tech machines and processes for industry. Some of these have been computer controlled with hundreds of inputs and outputs monitored and controlled in real time. I have patents on some of these machines and processes dating back to the 1970's. That being said I am amazed at some of the results from discoveries I made in December 2006. Much of it is flat out unbelievable to most people. What you are about to read is the truth. I will and have staked my life and entire life savings on it.

In December of 2006 I was working on controlling the flow of ions with a very unique array of magnets. I was doing this because of an understanding of the structure of matter that is entirely different from other physicists. This understanding of the structure of matter led to several breakthroughs in a very short period of time in late 2006. One of the most outstanding developments led to the completion of a machine on December 25, 2006. Because of this I initially called the machine the "Christmas Machine". We have since renamed this machine the HLX8 for marketing purposes. This machine was designed and built to heal the human body from outside using a structured tornado-like field of ions. This field of ions was then going to cause the cells within the human body to align to the optimum condition for health, life and treatment of many diseases. More specifically I designed this machine to eliminate cancer within the human body totally non-invasively. Well, almost unbelievably this machine has produced results that exceeded even my expectations.

As soon as I finished the first HLX8 machine I began using it on myself. Although I had no known cancer, I did have back problems that had bothered me for years. I also suffered from thoracic outlet syndrome (TOS) which would have my right arm and hand numb after using the computer for as little as one hour. I told a friend of mine about the machine and my results. He began to use the machine for his back problems that had plagued him for years. His name is Kyle and you can read his story along with others we have in our testimonials. Kyle also experienced dramatic results that left him feeling better than he had in years. Kyle came on board working with me to help get this technology out to the world in January 2007.

Over the next several months the HLX8 continued to amaze people with the results they were getting. On October 1, 2007 I was introduced to Emerson Timmins Head of Physics at the University of Hawaii, Maui (MMC). After talking to Emerson for a while I agreed to send him a HLX8 for testing purposes. Emerson also had some amazing results on both himself and others. You can read more about his account in our testimonials also. Emerson came on board with the project October 9, 2007 and is now more excited about it than ever.

Emerson introduced me to Maria Seiler who suffered from avascular necrosis of the talus bone in her ankle. Maria suffered a great deal of pain and could barely put any weight on that foot. No one over the age of forty ever really recovers from this injury – normally resulting in foot amputation. It is usually treated by joint replacement though this procedure is not always successful or long lasting. Well, as of today Maria has made an amazing turnaround using the HLX8 and is able to work without pain on her feet all day in her part-time job as an x-ray tech at a major orthopedic center that specializes in general, sports and joint replacement orthopaedics. Maria became involved in the project in about December of 2007 and works advising people on proper treatment with the HLX8 for various ailments. Maria also treated her friend Sue Bogle who had stage IV (the most severe stage) bone cancer with the HLX8. Sue was our first cancer patient and is now cancer free by using the HLX8. ON October 23, 2007 I was introduced to Fred Joyal who is the CEO and spokesman for 1-800-DENTIST [REDACTED] and Smileworks anti-aging centre [REDACTED]. I showed Fred an HLX8 and we tried it on a partner of his named Blake who had back problems. Blake also had great results from using the HLX8. Fred and I formed a California LLC. We have initially named the company Nebion LLC, but this must not be confused with another startup in Switzerland with a similar name that makes software for biological modeling [REDACTED]. The fact that the Swiss company talks about healthy cells versus unhealthy cells could cause many people confusion if they were looking for information on our company so we are exploring other names before we go public.

With Fred's financial and business support, further HLX8 machines were built and given to people with various ailments for testing purposes. Despite amazing results, so far the HLX8 does not appear to be effective in combating certain types of acute viral or bacterial infections.



SUGGESTED POSITIONING OF THE HLX8

The photos on the next four pages show some of the possible positions that the HLX8 can be used in. In general, the closer the head of the HLX8 is to the area treated the better and faster the results. As you can see in the illustration below, the strength of the field of ions is more intense and focused closer to the mouth of the HLX8 with the strongest part of the field being inside the HLX8.










You can see that the closer the head of the HLX8 is to the area of concern the better. There is no problem with your body actually touching the HLX8.




Sometimes there are several positions that will work just as well for treatment of an ailment. A headache can be treated by using the HLX8 as shown in photos A, B, U or V with equal results in many cases. Please observe the photos on the following four pages for some suggested positioning of the HLX8 to get ideas on how you might want to use it for your particular problem.

As you can see in some of the photos, you can use the HLX8 while reading, watching television, working on a computer, or any other activity that will allow you to remain in the field emitted from the unit. There is also no need to remove clothing whilst using the HLX8. It is better to remove heavy jewelry or clothing with a lot of metallic content as that might hamper the effectiveness of the ionic field the machine emits.









BIOGRAPHY FOR DAVE LAPOINT **INVENTOR OF THE HLX8**

Dave LaPoint has been developing new products and advanced processes for various industries for over 30 years.

He began working with machines when he was ten years old at his father Philip's manufacturing company that produced small consumer products. At his father's company Dave would file, sand and inspect small metal parts that he would then assemble into the finished item. By the age of 21 Dave had obtained his first patent and was skilled in many different forms of machining, welding and production processes.

When computer aided drafting started to become available Dave was one of the first to embrace this technology. He now uses 3d cad to completely develop new products on his advanced computer system before they ever exist in the real world.


I am the head of the physics department at the University Of Hawaii, Maui (MCC) and as such I get a plethora of self-proclaimed scientists asking me to discuss their new "breakthrough". I have very little time for this sort of thing. Then, a machine by the name of the HLX8 was brought to my attention. I have been scientifically investigating the seemingly unbelievable benefits of the HLX8 since. What we have unraveled to date have been some astonishing results.

What I found on a scientific plane is that due to its configuration, it creates an intense internal magnetic field that induces a force that will cause free ions to condense and accelerate uniformly away from the machine and that these ions will have an intrinsic rotation about their central axis configuration.


There is no substantial magnetic field outside of the machine. There is also no measurable radiation produced in any part of the device. I also found that non-magnetic substances (US Quarters) experienced a force when they were placed inside the center of the device that caused a lift (2mm or so) against gravity. The coins also increased in temperature by roughly 10 degrees Fahrenheit.

The machine was said to relieve the symptoms caused by: arthritis, muscle aches, cancer, poor blood circulation, and fibromyalgia. I am not a medical doctor, my precise field of study is experimental condensed matter physics. That said, my theory thus far is that the random free ions in air are being forced to become highly-ordered ions that are electronically polarizing the blood cells (each cell gets passed by the ionized field which forces positive and negative poles).

This polarization promotes the alignment with each nearest cell and the excess ions provided by the machine force the polarized cells to move. All cells will be forced into order. This highly ordered state assists the body in recognizing the cancerous cells and attacks them. Also, during the cell duplication phase of cancer growth in which cancer cells form an hourglass shape, the electric field stays on the perimeter of the cell (based on the electric field laws by Michael Faraday) and magnifies at the center of the dividing cells. This prematurely divides the cells and destroys them. The following link contains independent work done in Israel that supports this idea. This article is written by Katherine Bourzac MIT Technology Review Thu, 09 Aug 2007.



Blood tests such as C.E.A. on cancer patients using the HLX8 show an increase in the number of dead cancer cells in the body. This is due to the cancer dying from the field emitted by the HLX8. If the HLX8 is used too many hours per day the cancer in the body is killed too fast and this can potentially overload liver with dead cancer cells to be processed for elimination from the body. This could lead to a toxic situation in the liver and possibly cause nausea due to greatly overusing the HLX8. Simply reducing the amount of time that the HLX8 is used each day should eliminate this nausea side effect. Cancer needs to be killed at a rate that the liver can handle and no faster. This is usually no more than one hour per day with cancer patients.

My personal results:

- A large increase in energy, an increase in flexibility (I can now touch my toes), a reduction in recovery time from Lactic acid build up in muscles due to exercise or strain, the removal of a ½ golf ball sized callus on the top of my right foot, a thickening of my hair that was thinning on the top of my head, about a 2-fold increase in nail growth, a substantial reduction in the pain from a disc injury to my lower back dating back to 1995, and a softening of my skin.

I have witnessed:

- Susan, Delray FL: Diagnosed with stage 4 bone cancer. Sue was not able to move without extreme pain from fractures in her spine caused from bone deterioration and was too weak to walk. After two weeks of using the machine, Susan has since stopped taking her pain medicine and is sleeping through the night, walking, driving, eating out at restaurants and has regained her skin tone to its normal pinkish state. One month later, her doctors claim that they cannot find her cancer.
- Maria, Delray FL: a woman in her early 60s who shattered her talus bone and was unable to walk due to bone deterioration and swelling. Within 3 weeks she was able to spend the entire day walking on it without any support or pain. Maria is now able to ride a bike and can put all of her weight on her bad foot while on her tiptoes and is back working full time. She also noticed an increase in energy, a softening of the skin and claims her liver spots on her hands are 75% diminished.
- Lisa Torres, a young woman in her early thirties, has/had arthritis that was painful enough to make it nearly impossible to cut bread. She used the machine in front of me for 15 minutes and has been pain free for the last 5 months.
- Kathy Johnson diagnosed with fibromyalgia, who was unable to move her neck +/- 10 degrees and had trouble sleeping, used the machine for 20 minutes and instantly gained normal full range of motion.
- Eddie, Maui Hi: suffered from long term lower back pain to an extent that he was forced to roll out of bed onto the floor in order to slowly rise in the morning. He spent one hour under the machine, woke the next morning and sat up for the first time he was able to remember.

- Jeff, Oahu Hi, Diagnosed with small cell lung cancer and that had metastasized to the brain. Within six weeks, his doctors could not find the cancer.

There are multiple cases of the above mentioned and others unrelated, however, for brevity, I have simplified the list to these standard cases. Also note that C.E.A. levels in the cancer patients above have shown an initial increase in dead cancer cells as well as nausea until they reduced the time spent under the machine. Research needs to be done to explore the myriad of potential healing properties.

HLX8 FREQUENTLY ASKED QUESTIONS

Q What are the benefits of using the HLX8?

A We do not claim any benefits of the use of the HLX8 in order to comply with all the government agencies. We are merely reporting the benefits that users of the HLX8 have reported to us since it was created in December of 2006. Users have claimed the following benefits.

1. Cancer put in to remission (continued use should keep it as such). This includes stage IV that doctors had given up on.
2. Arthritis pain helped or removed.
3. Greatly accelerated recovery from various muscle sprains and strains.
4. Age reversal. This is throughout the body. Not only do users report feeling much younger they also look much younger. This includes grey hair reversal, younger and tighter skin, much greater endurance, greater sex drive and sexual enjoyment, greatly increased recovery time on physical exertion, increased balance and athletic ability and removal of age and liver spots. All the things that go with youth are basically realized by continued use of the HLX8.
5. Headaches removed in as little as ten minutes.
6. Recovery from long term injuries - including bones damaged by accidents.
7. Reduction of the effects from colds or flu. Example: sore throats and aches are much less painful within minutes of using the HLX8.
8. Carpel tunnel pain greatly reduced or eliminated. Users report that by placing the HLX8 next to them while working on the computer the pains that would normally occur are eliminated. This allows them to work all day on their computer or other tasks that would normally have them in pain and yet be pain free. One user reports total relief from thoracic outlet syndrome that would leave his right arm numb after using the computer for less than an hour. He is now able to work all day on the computer and be pain free with zero numbness.
9. Fibromyalgia pain reduced or eliminated by using the HLX8.

There are many other benefits that have been uncovered and certainly many more yet to come. Whatever your condition, the HLX8 may help you. You should

try it even if we don't have experience with your condition and see if it works for you.

Q What are the side effects of the HLX8?

A The only reported negative side effect is an anxious feeling similar to drinking too much coffee. This only happens after many hours of continuous use and goes away very quickly once the HLX8 is turned off or you move away from it. If the HLX8 is used as recommended then it is highly unlikely that you will ever experience this feeling.

A side effect which could be construed as a benefit is a large energy increase especially in the first few days of using the HLX8. Some have reported that this has led to trouble sleeping, but there is no tiredness the next day as you still have lots of energy. This energy side effect is less apparent after the first week or so of use.

Another side effect that would be considered a benefit to most people is the smoothing of the skin that occurs with continued use of the HLX8. After several weeks of use your skin will become noticeably softer and smoother.

In addition, another reported side effect of using the HLX8 would be the reversal of grey hair. If you have grey hair, continued use of the HLX8 could reverse your hair color back to what it was previously, but it may not do this evenly. So if your hair is grey it may become darker. If you dye your hair temporarily you can mask this effect until your hair is all one color. It is unknown how many years of grey hair can be reversed, but we have seen over 10 years of grey hair color reversal. So you can see the only real negative side effect is the anxious feeling that occurs when the HLX8 is greatly overused and again this will go away once you turn the HLX8 off or move away from it.

Some couples have reported an increase in sexual pleasure, performance and endurance.

Q How does the HLX8 work to correct INSIDE the body?

A This answer is not a claim but a theory based on the results that have been seen. Our current theory is that normal healthy cells line up in a row due to correct charge orientation in these cells (unhealthy cells do not line up normally due to incorrect charge orientation). The HLX8 emits a specially structured field that causes unhealthy cells to be forced into alignment or die, whereas healthy cells form even stronger and tighter bonds. Our current theory is that cancer for

instance is an irregular cell structure that cannot be aligned and live, therefore the cancerous cells die when forced into alignment by the HLX8.

Q Are there interactions with drugs?

A There have been no reported interactions of using the HLX8 with drugs. Caution is advised for any use of drugs with the HLX8, but once again we have no reported cases of drug interactions with the HLX8.

Q How long do I need to use the HLX8?

A This depends on what you are trying to treat. Some ailments can be treated in as little as 10 minutes whereas more severe ailments may need up to two hours a day. Cancer users should use the HLX8 for approximately one hour a day and should not exceed this amount until their C.E.A. levels drop below 20. Some users with cancer have reported a dynamic increase in appetite and energy levels within three days of beginning use of the HLX8. Depending on the cancer you are treating it can take anything between one and six months to become cancer free, the larger the tumor the longer it will take. Continued and correct use of the HLX8 should keep you cancer free.

Q Does the HLX8 have FDA approval?

A At the present time we are beginning the process of getting FDA approval for the HLX8 – although there is no requirement for such approval as The HLX8 emits no harmful radiation and it is totally non-invasive. No negative side effects other than those mentioned above are reported at this time.

Q What if you are pregnant or trying to conceive?

A We have no information at this time so we must advise caution in this area. From all other results we expect no negatives in this area and only benefits, but again we must advise caution if you are pregnant or trying to conceive.

Q Will using the HLX8 hinder the effectiveness of various birth control methods?

A This is unknown, but we have no reported cases of this being a problem. Caution is advised at this time. Certainly there should be no effect on condoms or diaphragms or their effectiveness in birth control.

Q Can more than one person use the HLX8 at a time?

A Yes. Depending on the effect desired you may have more than one person using the HLX8 at a time. For instance if your treatment requires you to only be three feet or less from the HLX8 then of course two people could both be three feet away and receive the benefits. For most conditions it is better to have the HLX8 dedicated to one user at a time. Of course many different people can use the HLX8 throughout the day and all will receive the full benefits of the HLX8 when used properly.

Q Will the HLX8 affect my love life?

A Users have reported only positive effects from using the HLX8. This includes greatly increased pleasure and stamina for both males and females using the HLX8 during sexual activity.

Q Will the HLX8 help with HIV or AIDS?

A We have no known users of the HLX8 with HIV or AIDS. We do believe that the HLX8 could be helpful in fighting off HIV or AIDS due to previous results with other problems. You can certainly try the HLX8 on HIV OR AIDS and return it after 60 days if you don't realize benefits from its use. The HLX8 should at the very least give HIV or AIDS sufferers increased energy and endurance at the very least. But once again this is only speculation based on theory and experience with other symptoms.

Q What about female menstruation?

A Some female users of the HLX8 have reported lighter and less painful periods. There have been no other reported effects of the HLX8 on menstruation.

Q What about using the HLX8 for ADD (Attention Deficit Disorder)?

A Users with ADD report a calming effect that helps them slow down and focus much better. An HLX8 placed in the area of someone with ADD may actually eliminate the need for drugs used for ADD. Caution is advised when any change in treatment of ADD is undertaken.

Q What are the long term effects of using the HLX8?

A Long term effects are not known at this time. Caution should be used when treating children and adults of child bearing age.

Q Will the HLX8 help with wrinkles?

A Users have reported greatly reduced wrinkles with long term use. Those using the HLX8 for more than six months have reported this effect as well as an overall change in their skin towards a more youthful appearance.

Q What about the mental effects of the HLX8? Will it give me bad thoughts or dreams?

A The HLX8 is reported to actually calm users down and give many a deeper and more restful sleep when used as directed.

Q What about animals? Will the HLX8 help my pet?

A Yes. The HLX8 emits a field that is beneficial to all warm blooded creatures. The same benefits that humans have experienced should also be realized by animals exposed to the field emitted by the HLX8.
