

SUMMARY OF [REDACTED] (1 of 3 Victims of PBSAO Prosecution)

Between 2004 and 2005, while [REDACTED] was a 16 and 17 year old high school student, she had approximately 15 encounters with Epstein. The first one occurred when an acquaintance asked her if she would like to make money by providing a massage to an older man. [REDACTED] heard that several high school students were doing this and making money, and [REDACTED] agreed to go to Epstein's residence. The acquaintance drove [REDACTED] the first time, and introduced her to Sarah and Epstein. The acquaintance took [REDACTED] upstairs to the master bedroom and bathroom, where a massage table and massage oils were prepared. Epstein entered wearing a towel. He told the acquaintance to wait downstairs for [REDACTED], which she did. Epstein removed the towel during the massage. While [REDACTED] massaged Epstein, he had [REDACTED] remove her clothing, which she did until her underwear. Epstein told [REDACTED] how and where to massage him while laying on his stomach, and when he turned onto his back. Epstein exposed himself and masturbated. [REDACTED] was paid \$200.

During subsequent encounters, Epstein exposed himself and masturbated. Epstein progressively escalated the incidents. Epstein began touching [REDACTED] on her buttocks and fondled her breasts with his hands as she massaged him. Epstein tried to insert his fingers in her vagina, but she backed away. Epstein occasionally offered [REDACTED] more money to have vaginal intercourse, but [REDACTED] repeatedly told him she would not do so. Epstein asked [REDACTED] to provide oral sex, which she refused. After a few encounters, Epstein told [REDACTED] he wanted her to have an orgasm and he used a back massager as a vibrator on [REDACTED], which he continued to do during these incidents. Epstein brought another female into [REDACTED]'s encounters, and Epstein told [REDACTED] and the other female to touch each other's breasts, which they did while he masturbated. A few times Epstein paid [REDACTED] more than \$200.

Epstein knew [REDACTED]'s age starting at 16. During these encounters, Epstein often talked to [REDACTED] about her interest in photography. Epstein gave [REDACTED] an Olympus digital camera, photography books, and several times told [REDACTED] he wanted to take her to NY, traveling together and staying with Epstein at his NY residence, so he could show her art and photography galleries. She refused his invitations. At [REDACTED]'s last encounter with Epstein, he presented [REDACTED] with lingerie, which she threw out after leaving Epstein without ever wearing, as a birthday gift for her upcoming 18th birthday. After Epstein gave [REDACTED] the lingerie, she massaged him. During that incident, Epstein forcibly penetrated [REDACTED]'s vagina with his penis. After that last incident by Epstein, [REDACTED] avoided all phone calls from Sarah, who ask [REDACTED] to return to Epstein to "work".

After [REDACTED]'s experiences with Epstein, [REDACTED]'s behavioral and emotional problems escalated. She suffers from depression, anxiety and sleeplessness.

In 2005, [REDACTED], a 17 year old high school student, was told by an acquaintance that [REDACTED] could be paid \$200.00 for giving a topless massage. [REDACTED] acquaintance had [REDACTED] and the acquaintance driven by taxi to Epstein. While the acquaintance remained downstairs, [REDACTED] was led upstairs to a bathroom area and shown oils and lotions to use. Epstein laid on his stomach on a massage table and [REDACTED] began massaging him. During the massage, Epstein turned over onto his back and [REDACTED] continued to massage him. Epstein told [REDACTED] to massage his nipples a specific way, which she did. Epstein told [REDACTED] to remove her bra, and she did so. Epstein exposed himself, and touched and played with his penis. While being massaged, Epstein talked to [REDACTED], and questioned [REDACTED] about her high school. When the massage was over, Epstein paid [REDACTED] \$200.00 and asked if she wanted to return. However, despite receiving calls inviting [REDACTED] to return, she did not do so.

Since [REDACTED] incident with Epstein, [REDACTED] dropped out of high school, became addicted to drugs, and has not been able to maintain any employment.

In early 2005, [REDACTED], a 16 year old high school student, was told by a friend that [REDACTED] could be paid \$200.00 from Epstein for massaging him. [REDACTED] was driven by her friend to Epstein's residence. [REDACTED] and her friend were led upstairs by another female to a bathroom by the master bedroom. Epstein entered not fully clothed. Epstein asked [REDACTED] about her hobbies. [REDACTED] and her friend removed some of their clothing. [REDACTED] and her friend massaged Epstein. During the massage, Epstein told the friend to go downstairs to wait for [REDACTED], leaving Epstein alone with [REDACTED]. Epstein told [REDACTED] to further undress and to continue to massage him, both of which she did. Epstein started his massage laying on his front and ended it on his back. Epstein then told [REDACTED] to lay on the massage table, which she did, and Epstein used a back massager on [REDACTED] as a vibrator. During the first encounter, Epstein exposed himself and fondled himself. [REDACTED] was paid \$200.00.

The second encounter was in early 2005. [REDACTED] was driven to Epstein by the same friend. [REDACTED] was led upstairs to the master bathroom area. This time, alone with Epstein, Epstein instructed [REDACTED] to get naked, which she did. Epstein started the massage while laying on his stomach, and during it Epstein turned over on his back. Epstein used a back massager on [REDACTED] as a vibrator. Epstein exposed himself and fondled himself during the second encounter. [REDACTED] was paid \$200.00.

Since [REDACTED] experiences with Epstein, [REDACTED] has suffered low self-esteem, anxiety, and embarrassment, among other emotional and sexual issues.
