**MOTION FOR STATUS CONFERENCE**

Counter-Plaintiff, BRADLEY EDWARDS (EDWARDS), by and through his undersigned attorney, moves this Honorable Court to determine the status of the above-styled cause, and in support thereof would show:

1. Counter-Defendant, JEFFREY EPSTEIN (EPSTEIN), moved for summary judgment on the claims asserted against him and the Court expressed its intention to grant Epstein's Motion.
