DRAFT STATEMENT

The allegations made against me by ██████████ are lies. I have consistently stated that they are untrue and I have waited for an opportunity to prove this in a court of law.

██████████, has never sworn to the truth of the allegations she makes. She is engaged in a campaign of media harassment with the objective of selling her memoirs to the highest bidder. The salacious claims she makes are untrue and made purely for financial gain.

The relentless media harassment to which I, Alan Dershowitz and Prince Andrew have been subjected to over the last week has become intolerable and breaches any justifiable sense of natural justice. I am therefore left with no choice but

to refer both the harassment and the unfair and untrue allegations to the press complaints commission with immediate effect.

I have never been engaged in any sexual conduct, as is alleged by [REDACTED]. I have never abused anyone, let alone a child and I find such conduct repugnant. I find the allegations offensive and deeply hurtful.

I met [REDACTED] when she was working at the Mar-A-Largo Country Club. I understood that she was at least 18 and was a masseuse not least because of her talking about her current 67 year old boyfriend. She subsequently came to Mr Epstein's house with her mother and brother. Ms [REDACTED] was interviewed by Mr Epstein.
