Dear [REDACTED],

Thanks for letting us know. Please write again after the wire transfer has initiated so that I can submit a claim for the payment.

It is unfortunately not possible to enter any portion of the [REDACTED]. What we could do at your request though is consider your application independently for the 2016-17 [REDACTED]. Since your admission to the [REDACTED] is being deferred, we will be contacting you again in September or October confirming that at that time you are still interested in joining the program. Please let me know then that you would also like to be considered for the [REDACTED], and we can do so.

You can qualify to sit for the [REDACTED] through either [REDACTED] of the [REDACTED] program, and I am honestly not sure which could prepare you better since the course content is the same for each program, although the timing is different. For instance, [REDACTED] is a course that counts toward [REDACTED]. If you take [REDACTED] during the summer it will occur every day for three hours over three weeks. If you take [REDACTED] during the fall, it would occur for just a few hours a week but for the entire semester. I will say that many students taking the [REDACTED], after completing the [REDACTED] program.

Dear [REDACTED],

I'm sorry for the delay in getting back to you. We can grant a one-year deferral of admission, to the 2016-17 [REDACTED].

Please be aware of our policy regarding your \$1000 nonrefundable deposit. This deposit fee is required to finalize your admission to the [REDACTED] program, and under normal circumstances would be applied toward your tuition bill during your first semester at [REDACTED]. If your deferral request is granted, you will be again required to submit a \$1000 deposit next year, which will be credited toward your first semester fees. Your initial \$1000 deposit will not be credited to your tuition, but instead be used to offset the administrative costs of processing deferrals.

If you agree to this policy and wish to secure the deferral, go ahead and pay the deposit in one of the methods listed on the Tuition Deposit Form on our admitted students website, and submit the form as well. Once those are received I will put the deferral in place and send confirmation. Please let me know if you have any questions.

Also, to expose you my question in writing beforehand :

I was admitted to [REDACTED] starting in [REDACTED]. Applying in January, i was certain to enroll then. However, the [REDACTED] made me an offer with fantastic salary that I could not refuse, to work for them until 30 June. I accepted to work because It will allow me to earn enough money to sponsor my living during studies at [REDACTED].  
Therefore, I would like to discuss with you the possibility to defer my entrance to the program for 2016 ?  
Also, I heard that it is possible to start [REDACTED] in June, after the 1st course ? Or, I can do 2-3 courses this summer, and another 4-5 courses next summer.

As I wrote to you before, an American company pays the tuition fees for me which can already be transferred to the [REDACTED] this month to secure a place for me for 2016.  
Since I am also a student of [REDACTED], I will have to do a mandatory training in [REDACTED] from January until June 2016 (6 months).  
If [REDACTED] accepts to defer my entrance to 2016, I will do an internship in July and August in [REDACTED] for [REDACTED]. The other 4 months of training would be January-April 2016. then, in May 2016 I can start [REDACTED].  
In October 2016, I will have [REDACTED] to pass.
