Spoke at
length with the OGIS assistance group re FOIA. They
actually think the FBI is one of the more responsive
agencies. They do what I have been doing with the Liaison
- extracting "estimates" of when a batch will be
produced. They will then communicate with me on your
behalf and close the file when that batch is produced thus
requiring us to make serial applications if we want them to
be a second voice pushing for compliance. I will trigger
this process (without a lot of faith it will help).

Ultimately, going to court is the only way to create an
enforceable schedule. OGIS told me that they are familiar
with schedules urged by DOJ OIP which are just ignored due
to agency resource limits.

Just spoke with Kendall about the basis for VR to be
listed. He agrees he has the better shot of discovering
that info which could also help Alan (clearly if there is
another witness rather than just a plane log that witness
did not ID Alan). He will make the call. Confirms he is
helping Alan identify a Broward lawyer which will then lead
to an investigator. I have seen inserts from Alan so I
