Oddly, we received a phone call from someone named Tiffany from Regions this morning. They asked my receptionist whether we represented you and if so, what matters we were representing you on. My receptionist confirmed that we represented you but correctly refused to tell her what matter or matters we represented you on. When she tried to ask what matter involving you she was calling about, my receptionist said she hung up. Very professional. I suspect she heard our auto attendant recording that we handle bankruptcy matters and she was concerned you were filing for bankruptcy. To the best of my knowledge I never got a phone call from Linda Conaway that was unreturned. Most of my communication w/ her was by email and I checked and don't see any response to my last email to her on April 13 except to ask for your tax returns on April 16. Very strange.



I confirmed that you had no ability or intention to pay \$209,000 and that we had made an offer to settle and had asked for a counter. I told her you really weren't interested in a payment plan but might be able to borrow some money from family to pay a lump sum. I suggest we counter at \$75,000 and see what she says.
