Dear Steve,

Since regrettably we were not able to come to an agreement on your separation from BRG Guest (the "Company"), we will be expecting you to fulfill all of your duties as CEO of the Company. We wish to point out that under your written employment agreement, you are required to "serve the Company and its subsidiaries and affiliates faithfully and to the best of [your] ability and devote [your] full business, time, energy, experience and talents to the business of the Company and its subsidiaries and affiliates."
