On Monday, December 29, 2014, Richard Kahn <[REDACTED]> wrote:

I spoke with vendor Brandon Thompson who did work on front door on December 19th and he explained to me that we cannot compare the two quotes as each job has a different scope of work

Stairs (bid attached) - \$13,535

refinishing wood and applying three coats of best varnish
(brandon states that scope of work here is most comparable to front doors that cost 11,750)
job will take 3 weeks if he has access to work 10-12 hour days and can begin immediately

Library (bid attached) - \$18,200

first will wash and refinish only 1/3 of space where bare wood is visible then apply 1-2 coats of wax (as opposed to varnish)
job will take 3 weeks if he has access to work 10-12 hour days and can begin immediately

Vendor would like a 50% downpayment before he starts each job and can start immediately

I will further negotiate his prices if you would like to proceed and if so which job would you like to start fist

Dear Mr. Kahn,

Thank you for sending me an e-mail letter requesting estimate to refinish Staircase from the first to the second Floor, at

9 East 71 st Street in NY City.

Mr. Delacruz told me that the present carpet will be removed and the Stairs will need durable and long lasting finish.

He told me that the Stairs will not be covered with carpet any more and the finish needs to withstand all the traffic. Having this on my mind, I suggest triple layer of the best varnish on the market. I also noticed that the surface to be treated is

double the size of the doors. Still, I need to work from the erected scaffold to reach all carved side decorations of the steps.

Estimate

For refinishing Staircase leading from the First to the Second Floor.

Surface to be refinished;

- 1. 29 steps and raisers 20"X72"290 square feet
- 2. Landing no. 1. 36 square feet
- 3. Landing no. 2. 36 square feet
- 4. Carved side to the first landing26 square feet
- 5. Carved side to the second Floor26 square feet

Total.....414 square feet of surface

Sand entire surface for smoothness with #120, 180, 320 grade of sand paper

Wash entire surface with Denatured Alcohol to remove impurities from the surface

Wash with Aceton to completely de-grease the surface to avoid the forming "fish-eyes" before the application of varnish.

Triple application of the best varnish on the market, sanding between the coats.

Total for labor\$12,600.-

Allow two day between next application of varnish.
