We will be most grateful for responses from Mr. Jeffrey Epstein on the following;

1. That [REDACTED] is Jane Doe 102
2. That Mr. Epstein regularly paid her a minimum of \$200 for sexual favors from the age of 15
3. That Mr. Epstein funded and organised a trip in March 2001 to Europe on which [REDACTED] travelled.
