DRAFT STATEMENT

The allegations made against me by [REDACTED] [REDACTED] are lies. I have consistently stated that they are untrue. Her statements have never been taken under oath

There has never been any criminal or claim made against me as relates to the prosecution on Mr Epstein in the matter of underage solicitation of a prostitute by [REDACTED] [REDACTED] or others, nor has the testimony of [REDACTED] or any of the other women in the civil cases against Mr Epstein ever been taken under oath. It appears that [REDACTED] is engaged in a campaign of media harassment with the objective of selling her memoirs to the highest bidder. The salacious claims she makes are untrue and made purely for financial gain.

The relentless media harassment to which I, and my friends have been subjected to over the last week has become intolerable and breaches any justifiable sense of natural justice. I am therefore left with no choice but to refer both the harassment and the unfair and untrue allegations to the press complaints commission with immediate effect.

I met Jeffrey Epstein and began working for him in 1992 which turned into a relationship that lasted until the end of 1999. At that time I was involved in overseeing some major projects which Mr Epstein asked me to continue with and, I agreed.

Throughout the entire time I was with Mr Epstein I never saw any improper conduct between him and [REDACTED].

I have never been engaged in any sexual conduct, as is alleged by [REDACTED] [REDACTED]. I have never abused anyone, let alone a child and I find such conduct repugnant. I find the allegations offensive and deeply hurtful

Mr Epstein had a large personal staff which included butlers, cooks, drivers, housemaids, masseuse, personal trainers and pilots. A substantial number of people worked for him. He worked hard, exercised, was very health conscious and took massages which I understood to be perfectly ordinary.

I met [REDACTED] [REDACTED] when she was working at the Mar-A-Largo Country Club. I understood that she was at least 18 and was a masseuse with a 67 year boyfriend. Mr Epstein was at that time looking for a part-time masseuse. I asked if she would be interested in applying for the job and she was. She subsequently came to Mr Epstein's house with her mother. Ms [REDACTED] was interviewed by Mr Epstein. I was not present as I remained with her mother chatting.

I did not go upstairs with [REDACTED] [REDACTED]. I did not take my clothes off. She had an interview with Mr Epstein and left the house with her mother.

Thereafter I do not recall seeing [REDACTED] [REDACTED] for a considerable period of time. I did not always accompany Mr Epstein when he travelled which was usually to do with his work. When I was in Palm Beach he was often not there and I was not always with him when he was there.

In 1999 [REDACTED] [REDACTED] began to travel with Mr Epstein as his masseuse. I had few direct dealings with [REDACTED] [REDACTED] as she was employed by Mr Epstein. I saw her from time to time.

In 2001 I was in London when [REDACTED] [REDACTED] met a number of friends of mine including Prince Andrew. A photograph was taken for her to show it to friends and family.

Prince Andrew and [REDACTED] [REDACTED] were at my house but I am not aware not saw anything improper that took place at my home. Mr Epstein was arrested about two years after I ceased working for him full time and five

years after we separated. I travelled less and less to palm beach. I have not seen US civil proceedings and the depositions which are referred to the in the press.

When Mr Epstein pleaded guilty, he stated that he would compensate any of his victims. This led to Scott Rothstein, an infamous US Attorney (now disbarred and serving 50 years in jail) creating false claims against Mr Epstein – this is fact. [REDACTED]

I am not going to engage in trial by media.

I will now report this matter to the press regulator as numerous offensive and untrue stories have been published about me without any prior warning. It seems that each week passes the allegations become ever more extreme and to date the press have failed to hold [REDACTED] [REDACTED] and her advisors to account and I call upon them to do so.

[REDACTED] [REDACTED] claims to have had sexual relations with many unnamed prominent business leaders, politicians and others. I believe these stories are also false

It is deeply regrettable that Mr Epstein abused minors but that does not give [REDACTED] [REDACTED] the right to make accusations against people who knew Jeffrey Epstein but had no knowledge of his crimes such as Alan Dershowitz and Prince Andrew, both of whom deny the allegations made against them.

Finally, I call upon [REDACTED] [REDACTED] to disclose her character. I believe she has past involvement with the police and at the time she left the US in 2002 had been arrested for stealing from her employer, a burger bar where she worked as a server. This is at the time that she claims she was a sex slave for the rich and famous, which shows that claim to be untrue. The reality is that [REDACTED] [REDACTED] was working as a waitress in a burger bar.
