> After having written them (Staley, McCabe, Baker) a few days ago suggesting we go our separate ways (because they had repeatedly failed to respond) McCabe asked me to give them another day or two. I did so, but McCabe again failed to call when he said he would. Staley then wrote to me personally and told me that if I could wait one more day he would call himself. He too then failed to call on the day he said he would. I could not wait for them any more.
