We do appreciate very much your efforts in trying to get your buyer to raise his offer closer to our asking price.

Nice to hear back for you.

I am sorry, but I am a little confused for what you write below. The normal base boat price with the Cummins 550hp and KaMeWa water jet drives is Euro 795,000.00 excluding all the extras and options. To this there is over Euro 80,000 worth of extras, that bring the price to Euro 875,600.

So why are you saying you were discounting the price from Euro 700K, which was already the 20% discounted price with extra options included?

I won't argue with you about the extras present adding value or not (we will leave this discussion for another time). But I would like you at least, as you say, to consider making your offer based out of the normal base price of the boat, which is Euro 795,000.

Good morning Richard,

Thank you for your preliminary proposal. Unfortunately your offer cannot be accepted, as the asking sales price has already been generously discounted for what is, in reality, a new boat.

I am afraid that you may have misinterpreted my definition of "demo" boat, used to describe the Black Shiver 140 which I've sent you the photos and is today being offered for sale.

This boat has been launched during the month of August and has been kept in the water for only 2 months, therefore it's already a 2017-year model. The engines have exactly 29 hours, done for testing and for the trip to the 2 boat shows it has been exhibited in September. Other than that, it has been kept dry-docking inside the yard's showroom.

For the light use we have done with it, we are offering the boat for sale at a 20% discount off the retail price of a new build. And as further gesture of good will to help the sale, we have offered at no additional cost to you, to replace the windshield, to convert the electrical system to 110V and to deliver the boat to the ship (cost of a 10h trip + the crew + the fuel).

Therefore calling it a "demo" boat is probably misleading, as when you can buy other shipyards' demo boats at bigger discounts, they are usually at least 2-years old boats with many more hours on the engines.

Here enclosed you can find the quote for the shipping directly to St Thomas. It is a unique opportunity to get you the boat delivered at destination in record time, without adding a 1000nm trip to the boat if instead it got shipped to Florida or elsewhere in another time of the year.

As previously mentioned, in order to get loaded on time for this ship, we must start working within the next week or so. Please let us know what your final decision will be and how further we can assist you.

Hello Richard,

For the Black Shiver 140 "demo" we have available for immediate delivery, we offered you a discounted price of Euro 700,000 instead of Euro 875,600. To this boat, I have received confirmation, we can replace the current windshield to the fully enclosed type (with wipers) as showed on the designs, and also change the electrical systems from 220V to 110V. The estimated time for the reworks is 30 days from when the deposit is received.

Furthermore, I have just spoken with the shipping company, and they are currently working on a new ship loading from the South of France (Marseille) with destination directly to St Thomas, around the first half of March 2017. The cost of this shipping is USD 20,500 water/water, including insurance and cradle.

Therefore, if you decide to chose to buy the demo Black Shiver 140 rather than a new-build, we can get you the boat delivered in the USVI by early April, hence skipping the 5-months construction time, plus waiting for another suitable ship to become available.

Given the 30-days work time required for the windshield and the electrical conversion, we would be just in time to make the loading on this ship! And to all this, as a further incentive to help the sale, we

will do this extra works at no additional costs to you.

Last but not least, we will also include the delivery and loading assistance of the vessel from the yard to the ship (roughly 270nm trip) at no cost!
