Per Mr. Fraguela's request, and per your approval, attached for your review and approval to proceed is the proposal from Jaca & Sierra for the core testing at the site you are considering for the GSJ Pool project.

Mr. Fraguela reviewed the proposal and his feedback is the proposal looks good, and the quote cost is less than he expected it to be.
