Monday they opened up the 1st and 2nd floor panels - They were forced to open both at once since they are both fed by the same circuit breaker

The 4th floor panel has not yet been touched and is fully operational along with the 3rd floor

There will not be any lighting all week other than temporary construction lighting (see photos below) which is allowing them to perform their work

Unfortunately they cannot stop job as panels are already open and do not anticipate any functionality until Friday afternoon

At that point in time there will be moderate functionality of the 1st and 2nd floors with 3rd and 4th floors remaining fully operational


