Hi, here's a summary:

1. Initial agreement signed between [REDACTED] [REDACTED] ([REDACTED]) & [REDACTED]. Contract ended in [REDACTED] and was not renewed yet [REDACTED]. You have a copy but basically it says that they pay us [REDACTED] - in addition to the [REDACTED]. Current portfolio's are [REDACTED] companies, [REDACTED]. As an example, [REDACTED] in sales in a [REDACTED] year period. We at [REDACTED] converted our [REDACTED] contract w/ [REDACTED] investment vehicle in each deal. We've always been more than aligned in the deals we sourced as we [REDACTED] helping them grow.

The context for this agreement was that they wanted to do deals in [REDACTED] and [REDACTED]. [REDACTED] also negotiate and get us to win the deals that were good, a good entry value, then [REDACTED]. [REDACTED]. [REDACTED]. [REDACTED]. [REDACTED]. This is exactly what is happening in a way as [REDACTED] [REDACTED] and force the sale of the portfolio companies.

2. In [REDACTED] they [REDACTED] as we had too much of a deal flow to handle alone. [REDACTED]. So part of what they say is that "things changed", that they need to figure out what will be of [REDACTED], that these are new times and paying anything needs to be much justified etc.

If going through another path is worthwhile [REDACTED] [REDACTED], ready to learn what that would be.
