This is to advise you of a further modification to Mr. Epstein's travel plans. Mr. Epstein plans to depart from his vacation home in New York a day later than anticipated. He plans to travel on October 2, 2017 from his vacation home in New York, New York to his vacation home in Paris, France. He expects to fly by private aircraft, N415LM, and arrive at Le Bourget Airport in Paris, France on October 2, 2017 at 8PM local time, and expects to stay at his vacation home in Paris, France until October 14, 2017.
