You are correct, you can PreClear US Customs in Montreal returning to US, however, this service is only offered to Airline flights, not private aircraft,.

I also followed up with Teterboro customs since they handle all private flights from Montreal, Customs in Teterboro indicated that Canada preclearance program use to exist for Private flights., but is no longer offered.

I'm waiting for Universal in Houston to confirm my findings as well.
